#### **ADMINISTRATION OF ACTS**

## Supplement to the General Order of 8 August 2007

I, John Mansfield Brumby, Premier of Victoria, state that the following administrative arrangements for responsibility for the following Acts, provisions of Acts and function will operate in place of the arrangements specified in the Administration of Acts General Order of 8 August 2007, in relation to the Act specified in the Order.

# Minister for Agriculture

Drugs, Poisons and Controlled Substances Act 1981 -

- Part IVA
- Part XI (This Part is jointly and severally administered with the Minister for Mental Health and the Minister for Health)

(The Act is otherwise administered by the Minister for Health and the Minister for Mental Health)

# Minister for Environment and Climate Change

Land Act 1958 -

- Except:
  - land described as Crown allotment 22D of section 30, Parish of Melbourne North being the site of the Victorian County Court

(These powers are administered by the Attorney-General)

# **Minister for Mental Health**
