Program: Barring Djinang Leadership Program

Program: First Mortgage and Community Infrastructure Program

The First Mortgage and Community Infrastructure Program (FMCIP) will fund up to 59 properties owned by Aboriginal organisations where the Minister for Aboriginal Affairs holds a first mortgage. Organisations can apply for funding to undertake necessary repairs and maintenance, and to develop a feasibility study in order to prepare them for the removal of first mortgage. Funding under the two categories, Urgent Repairs and Maintenance and First Mortgage Initiative, can support the applications for eligible organisations to have their first mortgage removed, although it is not required to seek funding ahead of this. Organisations who satisfy the First Mortgage Readiness Checklist will be eligible for the removal of the first mortgage, subject to assessment by an independent Advisory Panel and Ministerial approval. The FMCIP aims to support improved economic outcomes and to strengthen the sustainability of Aboriginal organisations in line with the principle of self-determination. It will enable more Aboriginal organisations to meet the emerging needs of their communities, such as in education, health and housing. It will also improve the ability of Aboriginal organisations to respond to the ongoing and changing demands in social, economic, legislative and cultural environments.

Program: OAAV Community Support Fund Initiatives

The initiatives funded under the Community Support Fund are consistent with the purposes of the Fund as outlined in the legislation, including youth programs, arts and tourism initiatives, and programs for the advancement of the community.
