LER Local Community Projects (Round 3) 2022-23

Funding under the Local Economic Recovery program for Round Three of the Local Community Projects (LER Rd 3) grants program will support projects that are important to achieving the aspirations and priorities of local communities.

Applications are open to applicants within eligible fire-affected regions identified in the Program Guidelines – LER Rd 3, with a focus on the most impacted regions of East Gippsland, Towong, and Alpine.

Please note, only one application can be submitted per organisation. Funding Available

For this round \$3.8 million has been allocated. The grant amount available is dependent on grant type:

- Infrastructure projects must seek a minimum of \$100,000, up to a maximum of \$2 million
- Programs and projects with a focus on the natural environment, social development, industry and business, aboriginal culture and healing, or adaptation must seek a minimum of \$50,000, up to a maximum of \$500,000

- Funding is for projects delivered and completed between 31 August 2022 31 December 2023

Project type

The grant amount available to an applicant is dependent on project type and the relevant LER project category.

• Enabling infrastructure: Applicants must seek a minimum of \$100,000 with a maximum available grant of \$2 million for infrastructure projects.

• Other project categories: Programs and projects with a focus on the natural environment, social development, industry and business, aboriginal culture and healing, or adaptation must seek a minimum of \$50,000 with a maximum available grant of \$500,000.

Please note, during the assessment period BRV will share the title of your project and a brief description of your proposal with Community Recovery Committees and Local Government Authorities. Location

Applicants must demonstrate that their project will occur in bushfire affected area and describe how the bushfires directly impacted on their community. As of June 2020, the following Local Government Areas (LGAs) and Alpine Resorts are considered within the scope of the program:

- Local Government Areas: Alpine, East Gippsland, Indigo, Mansfield, Towong, Wangaratta, Wellington and Wodonga
- Alpine Resorts: Falls Creek, Mount Buller, Mount Hotham and Mount Stirling

Criteria #1 - Local community benefit

Demonstrate how your project will deliver direct benefit to a bushfire affected community and supports one or more of the objectives.

Criteria #2 - Local participation and support

Describe how your project will support the engagement of local communities in recovery activities.

Criteria #3 – Planning and delivery

Provide a summary of key planning and delivery details below. Full details will be provided in your Project Plan (using the BRV template) and will be included in your assessment.

Criteria #4 - Alignment with Recovery Plans and other programs

Demonstrate how implementation of your project will align with the recovery needs or priorities identified in one or more of the local, State or National recovery plans (see below).

Criteria #5 - Long term outcomes

Explain how implementation of your project will deliver an ongoing benefit for the community through at least one of the LER long term outcomes.
