



Child Link User Training for Education Workforces

How to access the Information Sharing and MARAM Online Learning System (online learning system) and enrol in Child Link User training.

Accessing the online learning system

► Go to https://training.infosharing.vic.gov.au

Option 1: Log in to your existing account

- If you have previously used the online learning system to complete other courses, you will be able to use your existing log in to enter the system.
- If you have forgotten your log in details, please click the 'Forgot password?' link under the Log in button.

Option 2: Create a new account


- Click the 'Sign up' link under the Log in button.
- This will take you to a New Account page.
- You must fill in all fields with an exclamation mark (!)
- First, choose a username and password in line with the instructions on screen. We recommend using your email address as your username.
- Complete the More Details and About You sections.
- Complete the section About Your Organisation.
 - ► For **Sector**, select 'Early Childhood Education', 'School Education' or 'Other Education' (depending on where you work).
 - ► For Service Type and Organisation Type, select an option under heading 'Early Childhood', 'School Education' or 'Other Education'.
 - Complete the remaining required fields for your organisation.

Log into your account

- Once you have successfully created an account, you will receive an account confirmation email. Check your junk or spam folder in case it appears there.
- Confirm your account.
- Log in to the online learning system and register for Child Link User training (details on the next page).

Enrol in Child Link User Training

Before you can access Child Link, you need to complete training in the Information Sharing and MARAM Reforms (Information Sharing training), as well as Child Link. Information Sharing training is required to understand how information can be legally and safely shared using the Child Information Sharing Scheme (CISS) and Child Link.

Two training options are available for Education workforces. Please follow the steps below to ensure you enrol in the correct training course.

Decide which course is correct for you

Have you previously completed Information Sharing and Family Violence Reforms training? This includes:

- ▶ Education Professionals
- Education Leaders
- Information Sharing for Education Workforces
- ▶ Department of Education (DE) Regional Professionals

If your answer is **YES, I have completed an Information Sharing course**, go to **Option 1** to enrol in Child Link User Training.

If your answer is **NO**, I have not completed an Information Sharing course, go to Option 2 to enrol in Info Sharing + Child Link - Education. This course combines Information Sharing training and Child Link training into one session.


Option 1: Enrol in Child Link User Training

Choose this option **only** if you have already completed Information Sharing training (i.e., Education Professionals, Education Leaders, Information Sharing for Education Workforces or DE Regional Professionals).

If you have not completed an information sharing training course, go to Option 2.

Step 1: Enter the Child Link training page

From the **Home page**, select and 'Enter' the Child Link tile as shown in the images below.









Step 2: Sign up to your Child Link Webinar session

Child Link User Training All workforces.




On the **Child Link User Training Welcome** page, scroll to the heading **Child Link Webinar** and click the link that says, 'Please click here to pick an upcoming session'.




Option 2: Enrol in Info Sharing + Child Link - Education

Choose this option **only** if you have **not** previously completed Information Sharing training (i.e., Education Professionals, Education Leaders, Information Sharing for Education Workforces or DE Regional Professionals).

This course combines Information Sharing training and Child Link training into one session.

Step 1: Enter the Child Link training page

From the Home page, select and 'Enter' the Child Link tile as shown in the images below.




Step 2: Sign up to your Child Link Webinar session
