**Conveyancers (Fees) Amendment Regulations  
2025**

**1 Objective**

The objective of these Regulations is to amend the Conveyancers (Fees) Regulations 2018 to prescribe fees for the purposes of the **Conveyancers Act 2006**.

**2 Authorising provision**

These Regulations are made under section 188 of the **Conveyancers Act 2006**.

**3 Commencement**

These Regulations come into operation on 25 November 2026.

**4 Principal Regulations**

In these Regulations, the Conveyancers (Fees) Regulations 2018<sup>1</sup> are called the Principal Regulations.

**5 Regulation 5 substituted**

For regulation 5 of the Principal Regulations, **substitute—**

**"5 Fees for conveyancer's licence**

For the purposes of section 13(2) of the Act—

- (a) the prescribed application fee is—
  - (i) in the case of an applicant that is a company, 29.78 fee units; and
  - (ii) in the case of an applicant that is a natural person, 29.20 fee units; and
- (b) the prescribed licence fee is—
  - (i) in the case of an applicant that is a company, 20.51 fee units; and
  - (ii) in the case of an applicant that is a natural person, 22.36 fee units."

**6 Fee for application by person involved in claim for permission to hold, or continue to hold, a licence**

- (1) In regulation 6 of the Principal Regulations, for "is—" **substitute** "is 100.47 fee units."
- (2) Regulation 6(a) and (b) of the Principal Regulations are **revoked**.

**7 Fee for application by person with criminal record for permission to hold, or continue to hold, a licence**

- (1) In regulation 7 of the Principal Regulations, for "is—" **substitute** "is 100.47 fee units."
- (2) Regulation 7(a) and (b) of the Principal Regulations are **revoked**.

**8 Fee for application by company for permission to hold, or continue to hold, a licence**

- (1) In regulation 8 of the Principal Regulations, for "is—" **substitute** "is 100.47 fee units."
  - (2) Regulation 8(a) and (b) of the Principal Regulations are **revoked**.

## **9 Annual licence fee**

For regulation 9(a) and (b) of the Principal Regulations **substitute**—

- "(a) in the case of a licensee that is a company, 20·51 fee units; and
- (b) in the case of a licensee that is a natural person, 22·36 fee units."

## **10 Extension of time fee**

In regulation 10 of the Principal Regulations, for "on and from 1 December 2018 is 9·07" **substitute** "is 2·79".

## **11 Late payment or lodgement fee**

- (1) In regulation 11 of the Principal Regulations, for "fee is—" **substitute** "late payment or lodgement fee is 8·03 fee units."
- (2) Regulation 11(a) and (b) of the Principal Regulations are **revoked**.

## **12 Exemption from requirement to appoint manager**

- (1) In regulation 12 of the Principal Regulations, for "is—" **substitute** "is 49·56 fee units."
- (2) Regulation 12(a) and (b) of the Principal Regulations are **revoked**.

## **13 Employment of disqualified persons**

- (1) In regulation 13 of the Principal Regulations, for "is—" **substitute** "is 100·47 fee units."
- (2) Regulation 13(a) and (b) of the Principal Regulations are **revoked**.

## **14 Certified copy of, or extract from, the Register**

- (1) In regulation 14 of the Principal Regulations, for "is—" **substitute** "is 3·67 fee units."
- (2) Regulation 14(a) and (b) of the Principal Regulations are **revoked**.
